(ii) MTS from other Central Government / State Government / Central Autonomous Bodies / Statutory Bodies / PSUs, who have conformed in their parent organization after successfully completing the probation period, desiring transfer and possess the educational qualification prescribed for direct recruitment to the post of MTS.

- The Employee applying for transfer should have completed the probation period before applying for transfer.
- A minimum period of 5 years should be completed from the initial appointment before applying for inter-institutional transfer. Employee once transferred on own request, cannot apply for transfer for the next 10 years.
- Preference will be given to the officials of the ICAR system.
- The other terms and conditions for inter-institutional transfer will be as per ICAR guidelines Admn. 7-1/2020-R&P dated 23-08-2023 and other extant guidelines available on the subject.
